## ATTENTION EXHIBITORS

No entry can be accepted that specifies any conditions as to its acceptance. Entries will not be accepted without fees or signatures. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in event of errors found after closing date. Changes, additions or corrections to entry forms must be received in writing/email/fax prior to the close of entries. Those received by telephone are not acceptable.

No entry fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, strikes or any cause beyond control of the Club or Show Secretary.

**RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$30.00 to the amount of each returned check. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or a judge or barred from competition by action of the show committee.

*Bitches in season are not permitted in the trial.* One half of an exhibitor's entry fees will be refunded for bitches that come into season after the closing date, as long as the trial secretary is provided documentation from a veterinarian at least 30 minutes prior to the beginning of the day.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club nor the show secretary will be responsible or obligated to furnish any service for notifying the exhibitors or their agents of breed or class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. It is recommended to have on hand a current rabies vaccination certificate for each dog entered in the show.

The show giving Club, the Show Secretary, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assume no responsibility for injury to children. An AKC recording fee of 50 cents and a \$3.00 AKC Event Service Fee will be required for each dog entered. If a dog is entered in more than one class in the show the AKC Fees are to be collected on the first entry only (American Kennel Club Rule, Chapter 15, Sec. 2).
